## What is Missing in ACOs Today





Interview with: Robert Higgs, Founder and CEO/President, and Christopher Kellogg, Chief Operating Officer, ISeeYouCare, Inc.

"Most ACOs lack the technology that would truly achieve care across the continuum as established by CMS. Interoperability, being the overall mission of the ACO Program. Meaning, ACOs must have the ability to track and monitor a patient's care when receiving medical services outside their own healthcare system. Achieving that one specific objective would provide every care provider, at the point of care, the ability to make the most clinically informed decision on behalf of the patient which results in better outcomes. ISeeYouCare believes there are two components to the healthcare system that are relevant, a patient and a care provider. Both are singular in nature and only one is mobile throughout their lifetime, the patient," according to Christopher Kellogg Chief Operating Officer, **ISeeYouCare**, **Inc**.

"There are currently over 400,000 preventable deaths in hospitals every year and over USD 700 billion spent on unnecessary diagnostic tests. There is

so much more that we can do to reduce those numbers," suggests Robert Higgs, Founder and CEO.

### What is missing from most health platforms and EHR systems?

Higgs: What is lacking today is a virtual, longitudinal medical history of every consumer that is transferable, transparent, controlled and owned by the consumer. People are mobile, so they must own their records wherever they are, and be able to share it securely with their provider.

# How does your platform differ? How does it enable people to have a healthier lifestyle and manage chronic conditions better?

Kellogg: Our platform can communicate with other disparate systems, collect information and aggregate it back to our system, so that patients have an allencompassing universal record. It has clinical decision support tools built-in to help people achieve a healthier lifestyle. This game-changing platform is the only one in the market that allows doctors to see all the information they need on a patient.

Higgs: ACOs were created to provide continuum of care across the entire healthcare landscape. There was never a provision for EHR systems in ACOs to communicate with each other. At the moment, in a best-case scenario, providers might take the time to call another care provider's office and ask them to fax a record. Faxed and scanned records represent unstructured and non-actionable data, making it difficult for care providers to use that data in any meaningful way.

ACOs can license a Universal Personal Health Record (PHR) to augment their EHR, and get full access to all 17 sections of a patient's record including all imaging. The solution supports Chronic Care Management, eTelehealth, Remote Monitoring and more. Remote monitoring enables a Hospital to monitor a patient's health vitals and more post discharge in real time.

## What potential does this technology hold for cost reduction?

Kellogg: It reduces fraud and unnecessary tests. When patients present at a point of care medical facility with all their history, there is no need to re-run all the tests. According to the GAO, the costs associated with redundant and unnecessary diagnostic test represents USD 700 billion a year, almost 20 percent of US healthcare.

Higgs: Even after spending hundreds of billions of dollars on electronic records, the latest statistics show there are over 400,000 preventable deaths in hospitals each year. That makes it the third leading cause of death in the US behind heart disease and cancer yet nobody is talking about it. The key word is that this is preventable. Heart disease and cancer are not necessarily preventable, but unnecessary deaths due to errors are. That is the mission for our company. We want to contribute to the reduction in those numbers.

Physicians can finally be in that ideal position with 100 percent of a patient's history in front of them
